**Confirmation of the minutes**

## Materion yn codi:

## Gohebiaeth

**Goleuadau Nadolig:** Adroddwyd bod y Cyngor Cymuned wedi cael cais i gyfrannu at gost goleuadau Nadolig ar Bont Llan. Bydd y Clerc yn gofyn faint o gyfraniad sy'n cael ei ofyn amdano.

## Adroddiad Cyllidol

Nodwyd bod £8,938.13 yn y banc.

**Talwyd y biliau canlynol:** Clerc (Archwiliad) £250, E.ON (Toiledau cyhoeddus) £20, Eglwys Unedig (Llogir Neuadd) £120, Eglwys Unedig (Glanhau'r toiledau) £480, Google £9.20, OG Evans (Torri gwair y fynwent) £1,600, HSBC £10.30

## Praesept

Roedd trafodaeth fanwl am braesept a'r pwysau ariannol sy'n wynebu'r Cyngor yn y flwyddyn i ddod. Ar adeg pan fo pawb yn y gymuned yn wynebu mwy o bwysau ariannol, cytunwyd yn unfrydol i gynyddu'r praesept dim ond ychydig i £7,500.

## Matters arising:

**Public Toilets:** It was reported that a trench needs to be dug behind the building. It was decided to contact the landowner.

**Arwelfa Cemetery Wall:** The Council is awaiting one more quote. It was reported that someone has driven into and damaged the gates.

**Lorries in Cwm Penmachno:** It was decided to contact the Welsh Government again and the County Council.

**Tyddyn Gethin:** A date will be arranged soon for a site visit.

**Gorlan:** It was reported that the owner has started advertising the site through Airbnb again. The Park Authority are in the process of writing to the owner.

**Community WiFi:** It was reported that Openreach had installed the internet connection. Volunteers from the village are ready to start work on the 'free-Wifi'.

## Correspondence

**Christmas lights:** It was reported that the Community Council had been asked to contribute to the cost of Christmas lights on Pont Llan. The Clerk will ask how much of a contribution is being asked for.

## Financial Report

It was noted that there was £8,938.13 in the bank.

**The following bills were paid:** Clerk (audit) £250, E.ON (Public toilets) £20, Eglwys Unedig (Neuadd hire) £120, Eglwys Unedig (Cleaning toilets) £480, Google £9.20, OG Evans (mowing cemetery) £1,600, HSBC £10.30

**The following was paid in:** Money from public toilets £53.60, Conwy County (Community Toilet Scheme) £500, (precept) £2,000, (Picnic table grant: 80% excluding VAT) £2,308, Penmachno Charity (Wifi grant) £800

## Precept

There was a detailed discussion about precept and the financial pressure faced by the council in the coming year. At a time when everyone in the community is facing increased financial pressure, a modest increase to £7,500 was agreed unanimously.

## Materion Cynllunio

**Llwybr Cyhoeddus 55: Pen-y-Waen - Stryd Llewelyn:** Mae'r mater wedi ei adrodd i'r Cyngor Sir. Penderfynwyd adrodd am y broblem i Openreach am fod dŵr yn llenwi eu blwch tanddaearol.

**Glanhau'r Toiledau Cyhoeddus:** Cytunwyd yn unfrydol y dylai'r taliad blynyddol godi i £520.

**Bagiau Halen:** Cytunwyd i brynu mwy o fagiau halen/graeon rhag ofn y tywydd rhewllyd.

## Planning

There were no new planning applications.

**Machno Inn:** It was reported that a letter had been written to the owner of the building and a reply received. It was decided to wait until the next meeting and see if there is a noticeable improvement in the site.

**Swch:** It was reported that the caravan is now vacant and has been condemned.

## Other matters

**Public Footpath 55: Pen-y-Waen - Stryd Llewelyn:** The matter has been reported to the County Council. It was decided to report the problem to Openreach because water is filling their underground box.

**Cleaning of the Public Toilets:** It was agreed unanimously that the annual payment should rise to £520.

**Salt Bags:** It was agreed to buy more salt/grit bags in case of freezing weather.
